

- 2. Bank Savings Account Number for Freeship / Scholarship:

All students should produce details of his /her savings account of any nationalized bank. If he/she doesn't have it, then the student has to open a savings account immediately in any nationalized bank. In case, the student is minor (age below 18 yrs) then, a joint account with the parent has to be opened with the student as 1st account holder. The savings account is a very useful document for various scholarships/Freeship/EBC scholarships of Govt. of Maharashtra.

Miscellaneous:

1. In case <u>ORIGINAL DOCUMENTS ARE NOT AVAILABLE</u>: If a candidate is unable to produce original document/s if any at the time of admission on account of admission already taken elsewhere then he / she has to submit a BONAFIDE certificate issued by Head of concerned institute/College stating that candidate has been admitted to a particular course in that institution on a particular date and original certificates are retained by the institution. In such cases a candidate must produce the copies of the certificates duly attested by the Principal/Head of the concerned institution. Such candidates are

- 3. <u>COMMENCEMENT OF CLASSES</u>: Classes will be started regularly as per the schedule declared by cet cell probable from 01/09/2024 (First year) For DSE Classes already started. Time table displayed on Institute Notice board/Institute website.
- 4. DSE students should meet their respective Head of department after the admission confirmation for further instructions as their teaching is already started.
- 5. <u>INDUCTION PROGRAM</u>: Induction program for **first year students** is introduced to familiarize them to the new environment and encourage them to look beyond classrooms. Objective is to help new students adjust and feel comfort-able in the new environment, inculcate in them the ethos and culture of the institution, help them build bonds with other students and faculty members, and expose them to a sense of larger purpose and self exploration. The date of **The induction program is mandatory to all students as per AICTE instructions. All should join it as per schedule displayed on the Institute notice board.**
